## Inheritance: Blood, culture and land heritage

### ARTICLE SUMMARY

The article, *'The signs of the times: the mark of the beast is a metaphor'*, revealed that the people and nation of Israel holds the spiritual title of 'Egypt and Sodom'. This article was written to elaborate upon this historical and part revelation-like concept (Elekwachi, 2021d). The Lord's heritage, and therefore His inheritance is based on three crucial factors: blood, culture and land heritage. Together, it is these three factors which have long determined the Lord's heritage during the "end of the age", thereafter and forevermore. The importance of defining heritage is essential because it allows for a clearer connection to be made between Biblical history, prophecy and the real world: therefore, highlighting the Truths of the Holy Bible – a Word which does not lie. Hence, let it be known once again that the Lord's heritage are the Christian people who are indigenous to the Biafran nation (Igbo's and other Biafran peoples): who are the Lord's natural and firstborn son i.e. the male child (baby) of the woman depicted in Revelation 12, which also foreshadows that some revelations are inseparable from history.

#### BIBLICAL CONTEXT: AN IMPORTANT SCRIPTURAL REVELATION

For the purpose of Biblical context and further Biblical understanding, it makes sense to reiterate the Scripture Romans 2:1-2, which states that the Truth of salvation and God-given prophetic knowledge and understanding only originates from those of His heritage:

- *Romans 2: 1-2* – <sup>1</sup>Then what advantage does the Jew have? Or what is the profit of circumcision? <sup>2</sup>Much in every way! Because first of all, they were entrusted with the revelations of God.

Therefore, it is of note that the word “Jew” is only a translation label that is used in the Bible, but in Truth only correct labels are valid. This means that the people of God’s actual heritage are who’s referred to or connected to in the Bible when the word “Jew” or “Hebrew” is used. As a result, it does not matter and never mattered what The Lost Tribes of Israel were/are called, whether it is Ndigbo (Ndi-Gboo) meaning “the ancient people”, Hibiru, Ebo, Igbo or Eboan – and this same concept also extends to other Biafran people descended from the Ancient House of Israel (Akannam, 2012b, Elekwachi, 2020b). Am I not obviously a Biafran Igbo? The answer is yes, and so, it is clear that my people are God’s heritage. Therefore, a “translation label” is overridden by multiple factors of Truth (1) direct patriarchal descent that is based on significant blood ties to the Ancient House of Israel (2) the maintenance of the Mosaic Law as a way of life (traditional culture) (3) land heritage and (4) spiritual title, which is not only bestowed upon people by God (the Father), but to lands and locations. For example, in the Bible “Israel”, “Zion/Mount Zion” and “Arzareth” refers to the Biafran land, with “Zion/ daughter of Zion”, “Israel”, “Jacob” and “Ephraim” also referring to the people of the Lord’s heritage. Therefore, understanding the context in which Scriptures present information is also essential to Biblical interpretation, as these titles can also refer to individual people, for example, I hold multiple spiritual titles – I will not reveal them all, but let it be known that Ariel, Wisdom, the shoot/stem/branch of Jesse (most likely linked to actual descendancy); Mount Zion; Elijah; King David; Israel; Jacob; and Servant (Jesus also held the spiritual title of Servant, and so, in my case it is a unique “one in Christ” circumstance where the Lord works through me i.e. if a certain Scripture says that God is doing something, then I would be doing it instead). More so, I am also the woman from Revelation 12 i.e. the anonymous source from the article, *‘The signs of the times: the mark of the beast is a metaphor’*, so let it be known that not one ounce of information from it was hearsay.

The result of acquiring multiple spiritual titles is the prompting of Scriptural prophecies, or making some related Scriptural prophecies relevant once again, whether blessing or curse (despite my own innocence) i.e. some chapters from the Book of Isaiah, Jeremiah and the Psalms are relevant to these times, but others are not. It is also worth noting that the 4 Gospel’s of Christ’s Apostles are not being repeated, as there is only one Lord Jesus Christ, however, many of the parables that the Lord spoke during His first messianic advent are being fulfilled. Therefore, let it be made clear that the Lord, Jesus Christ (obviously not his true Name) is an actual Igbo man who will return to His home, which is Biafra. Overall, this means that a location in the land of God’s heritage (Biafra) would assume the spiritual title of the ‘Mount of Olives’. This means that any Biblical prophecies linked to the ‘Mount of Olives’, which refer to the Second Coming of Christ are actually associated

with the unknown Biafran location, while the original Mount of Olives in Israel remains unassociated with the Lord's home-coming messianic events because it is 'Egypt and Sodom'. Therefore, let it be known that the "one not born of a woman" (Miller, 1992) from the Gospel of Thomas is the Lord, Jesus Christ, who has been about 30 years old since His resurrection and ascension to Heaven i.e. when He returns He would be a human that was not born from their mother's womb during this lifetime. However, before the return of the Lord there are more things that must take place such as (1) the final salvation effort needed to establish legitimate church assemblies across many different nations, and (2) the establishment of the Biafran nation and the return of its indigenous people to their homeland.

For clarities sake, the JBEP article, '*The signs of the times: the mark of the beast is a metaphor*', already made it clear that many of the "end of the age" prophecies have already been partially fulfilled, but it is worth providing a description of a clearer "timeline" (Elekwachi, 2021d). For example, the Lord's marriage to His future wife will obviously not occur until the divine judgment of the "end of the age" is over (Revelation 19:6-9, Psalm 45), while other events would take place within a decade or a thousand years later, but immediately following the Lord's return is the resurrection of "sleeping Christians" (physically dead, but not spiritually dead):

- People from the occult who refused TMOTB and were killed (sacrificed) for it (Revelation 13:15)
- The Christians (saints) given over to the sword (Revelation 13:10)
- The faithful Christians from the Church in Smyrna (Revelation 2:8-11)
- The Lord's past Servants, Prophets, Apostles and people (actual Christians) whom He promised life to in the "new age of Christ" (Revelation 6:9-11) – these would most likely be His servants and prophets like John the Baptist (who once held the spiritual title of Elijah, as did Elisha (2 Kings 2:9-15), more so, John was most likely the reincarnated soul of Elijah i.e. his clothing (leather belt) is an obvious clue (Matthew 17:11-13, Matthew 3:4, 2 Kings 1:8); Jeremiah; the Apostles including Paul, as it was inferred that the original Apostle's would die at the "end" of their service (John 21:23-25); and the unknown and unrecognized Servant's, Prophets and Apostles of past times who didn't get to enjoy their lives because of the circumstances in which they served the Lord, the Most High God (Chukwuokikeabimá).

Furthermore, because I hold the spiritual title of the Prophet Elijah, the Scripture Matthew 13:57 takes effect: *"They were offended by him. But Jesus said to them, "A prophet is not without honor, except in his own country, and in his own house."* Hence, for obvious reasons my country of normal residence, which is Australia, is not suited to establishing fruitful Christian endeavors, more so, it

is part of the Babylonian satanic league of nations, who actually planned, carried out and committed the “abomination of desolation” against me – but perhaps repentance may still be considered by Australians of Indigenous, English or other heritage, and so, blessed are those who have another home country, and may the truly repentant be saved. Finally, it also needs to be reiterated to those who continue to persecute me that I cannot “taste death” (die), and so, any efforts attempted against me are futile and would naturally result in a high personal cost i.e. any hostile and unsavory acts are equivalent to “spiritual suicide” or a one-way ticket to Gehenna (hell).

### **THE NATION OF ISRAEL HOLDS THE SPIRITUAL TITLE OF ‘EGYPT AND SODOM’**

Revelation chapter 11, verses 11:1-2, reveals that a church (synagogue or temple, whether a building, buildings or an entire zone, of which there could be many) will be a refuge for Jewish worshippers of the Lord, the Most High God (Elohim), who live in Jerusalem during the final times of divine judgement.

- ***Revelation 11:1-8 – <sup>1</sup>A reed like a rod was given to me. Someone said, “Rise, and measure God’s temple, and the altar, and those who worship in it. <sup>2</sup>Leave out the court which is outside of the temple, and don’t measure it, for it has been given to the nations. They will tread the holy city under foot for forty-two months. <sup>3</sup>I will give power to my two witnesses, and they will prophesy one thousand two hundred sixty days, clothed in sackcloth.” <sup>4</sup>These are the two olive trees and the two lamp stands, standing before the Lord of the earth. <sup>5</sup>If anyone desires to harm them, fire proceeds out of their mouth and devours their enemies. If anyone desires to harm them, he must be killed in this way. <sup>6</sup>These have the power to shut up the sky, that it may not rain during the days of their prophecy. They have power over the waters, to turn them into blood, and to strike the earth with every plague, as often as they desire. <sup>7</sup>When they have finished their testimony, the beast that comes up out of the abyss will make war with them, and overcome them, and kill them. <sup>8</sup>Their dead bodies will be in the street of the great city, which spiritually is called Sodom and Egypt, where also their Lord was crucified.***

- **NOTE:** The identities of the Lord’s two witnesses are not currently known, but their identities have long been suspected based on Biblical evidence.

Therefore, because it is plainly written in the Bible that Jerusalem will face difficulties, it is only logical that God’s Jewish people in Jerusalem would be “set apart” for the sake of their own wellbeing, as it is clear that not everyone in Israel (or any other nation) will be saved by the Lord. Therefore, there would be peace for Christians, but not for the unsaved. As a result of such circumstances, it is most likely that the bitterness of Jerusalem’s unsaved populace that causes

them to “trample the great city underfoot” i.e. non-Christian people choosing outright rebellion over repentance in the times of final judgement. Hence, Revelation chapter 11 is without a doubt a reference to future events that have not yet happened, but when it does happen, it is clear that the Lord will protect and shelter His Jewish people, both faithful and repentant Christians (those who have received the Holy Spirit by that time). The above may lead to the question, ‘*Why is Jerusalem still referred to as the “holy city” or the “great city” in the Bible?*’ The truthful answer is that it is solely for the purpose of discerning the Truth, whereby the intentional use of the spiritual title, ‘Egypt and Sodom’ makes it clear that Jerusalem and therefore the nation of Israel, and its people are not the Lord’s heritage. After all, it is written in the Bible that there are Jews who call themselves Jews, but are not, and it is known through Biblical evidence and research that it is the Jewish people(s) (Revelation 2:9, 3:9). The “real Jews” are obviously the Igbo and Biafran peoples whose descendancy from the Ancient House of Israel has been suppressed and ignored despite significant and known evidence that is literally centuries old (Elekwachi, 2020b). Therefore, present day Jerusalem is only called the “great city” and “holy city” for clarifying purposes, because within the context of the “end of the age” and the forthcoming new age (the age of Christ): the “new Jerusalem” (holy city) has yet to be established, but it will be located in the land of God’s heritage, the Igboland of Biafra, which is the true home and heritage of the Lord’s beloved church, the ‘church in Philadelphia’.

### **INHERITENCE IS BASED ON PATRIARCHAL DESCENT – BLOOD & CULTURE**

There is a substantial body of factual evidence that indicates that Jewish (Israeli or other) people are a population with various dominant heritages, as indicated by how they identify i.e. Ashkenazi Jew (European), Sephardi Jew (Spanish or Hispanic) or Italian Jew, which suggests (1) the conversion to Judaism due to the occupation of Israeli territory (2) the severe dilution of the original bloodline due to exile intermarriage and (3) heavily diluted blood ties to the Ancient House of Israel through matrilineal descent, which is a presumed attempt to find a “backdoor” into God’s heritage. However, such actions naturally diminish or rather eliminate a bloodline, and therefore, “how much” blood becomes a significant determining factor of God’s inheritance.

- (1) It is known that Jewish populations have heavy multi-generational admixture that has occurred over 1600-3400 years, due to “conversion” and the foreign occupation of Israel i.e. Romans and Arabians (Sorek, 2002, Das et al., 2017, Moorjani et al., 2011, Ramsay and Holum, 2015). The Bible also provides evidence of Roman and other foreign occupation of the southern kingdom of Judah at the time of the Lord’s first messianic advent; while the Northern Kingdom of Samaria, was occupied by Samaritans, who were also a foreign people (Elekwachi, 2020b). For example, it is known that the Israeli “king” during the Lord’s first advent, Herod Antipas, the tetrarch of Galilee and Peraea from 4 B.C.

to approximately 39 A.D., was of Roman and other heritage (Hoehner, 1980). A foreign ruler in Galilee and Peraea, which were part of the Southern Kingdom of Judah, reflects the state of Judah's covenant with the Lord, broken, and this is because foreign invasion or occupation is a known curse of the Old Covenant, and the consequence of disobedience i.e. disregarding the Lord's commandments (Deuteronomy 28:30-33, 36, 43) (Elekwachi, 2020b). A foreign ruler or "king" also infers a significant foreign population amongst the people of ancient Israel. This means that many of ancient Israel's population during the time of Christ's first advent were not even part of the Abraham-Isaac-Jacob bloodline. Therefore, many of the people who lived in ancient Israel are better described as colonizing sojourners, regardless, it is such sojourners that have become the people who live in the land called Israel. Hence, Jewish people are more accurately defined by their original proselyte (convert) identity, for example, a Roman proselyte is the same thing as an "Italian Jew" or an Italian person who practices Judaism,

(2) It is known that many "Jewish" people of the past lived in exile due to their sins, and so, the result of intermarriage between exiles and gentiles would have naturally led to the dilution of the original bloodline (EB, 2021b, BDP, 2016). Hence, the consequence of multigenerational admixture is simply the weakening, or rather breaking of blood ties to the Ancient House of Israel (Moorjani et al., 2011, Siegel-Itzkovich, 2006). The reason for this phenomenon is that the people who were originally "Jewish" became other people i.e. gentiles who maintained Judaism as a form of religion. For example, this is the known history of the Sephardi Jews who fled to Spain, Portugal, Rome, and other European countries in times of "Jewish exile" (EB, 2021b).

(3) By evidence of the Holy Bible, it is clear that the Lord does not recognize matrilineal (maternal) heritage, but only direct patriarchal heritage as indicated by the numerous male only genealogies from Adam to Abraham; Jacob and his sons, the 12 patriarchs of Israel; and the House of King David. For further emphasis, the Lord Jesus Christ was said to be of the House of Judah because his adoptive father, Joseph, was a direct descendant of King David: *23 Jesus himself, when he began to teach, was about thirty years old, being the son (as was supposed) of Joseph, the son of Heli," ~ Luke 3:23.* However, it is known that Jesus' mother, Mary (Amara), was a Levite, as she was the cousin of Elizabeth, the mother of John the Baptist, yet, Jesus' Levitical heritage is not mentioned in the Bible, and this is simply because only patriarchal heritage is recognized by the Lord, the Most High God (Akannam, 2012a). This same cultural custom of patriarchal heritage is still maintained by the Igbo people to this day, along with a multitude of Mosaic-style cultural practices that are not maintained as part of religious practice, but of the Igbo peoples way of life, which is

reflected by its peoples traditional approach and preference in lifestyle choices (Elekwachi, 2020b).

More so, it is known that in the past Jewish Rabbi's continually pushed the "matrilineal principle", which was used to claim that being a natural born Jew was/is inherited by a child through their biological mother (Sorek, 2002). However, it is suspected that the real reason for the practice of the "matrilineal principle" was an attempt to maintain some sort of "legitimate" blood tie claim to the Ancient House of Israel, as there is the common practice of tracing "lineage" through mitochondrial DNA (Siegel-Itzkovich, 2006). Mitochondrial DNA is only inherited from a person's mother, and in this circumstance tracing it could be considered an endless genealogy, which is comparable to an overly complex family tree used to trace minor component of a peoples descendancy (1 Timothy 1:4). However, it appears that the use of the "matrilineal principle" stems from what is essentially ethnic cleansing (genocide) that only aims to (1) "replace" the people of the Lord's actual heritage and (2) "maintain" a "legitimate" blood tie to the Ancient House of Israel. Therefore, where there are people proclaiming to be "Jewish" despite the fact of "blood and race", it is important to look at the finer details of their "argument". For example, the article, '*Gene tests show that two fifths of Ashkenazi Jews are descended from four women*', by Siegel-Itzkovich (2006) confirms that many European Jews are the result of matrilineal descent, and so, it remains that their modern-day offspring have no direct patriarchal descent, and little-to-no blood ties due to significant generational admixture (Siegel-Itzkovich, 2006, EB, 2021b, Moorjani et al., 2011).

Based on the above, the importance of blood heritage is obviously common knowledge when it comes to God's inheritance, especially among those who are born of intermarriage, because it appears that the Ashkenazi Jews of the past may have attempted to "maintain" stronger blood ties to the Ancient House of Israel through incestual practices. This is expressed because there are approximately 20 recessive inherited genetic diseases that are known to the Ashkenazi Jew gene pool, and it is common knowledge that higher levels of recessive hereditary disease are a typical pattern seen among inbred populations (Siegel-Itzkovich, 2006, Bischof, 1972). For example, Tay-Sachs disease is a recessive hereditary disease that is rarely found in other groups of people, but is frequently found in the Ashkenazi Jewish population (Bischof, 1972, Siegel-Itzkovich, 2006). In simple terms, a recessive hereditary disease is a condition that is the result of both parents being carriers of a disease i.e. people with a "healthy" gene that masks the effects of the "unhealthy" gene, but the "unhealthy" gene from each parent is passed onto their child/children who receive the full condition. Overall, this emphasizes why certain types of sins are discouraged by God: there are biological consequences that are the direct result of breaking natural laws, which are



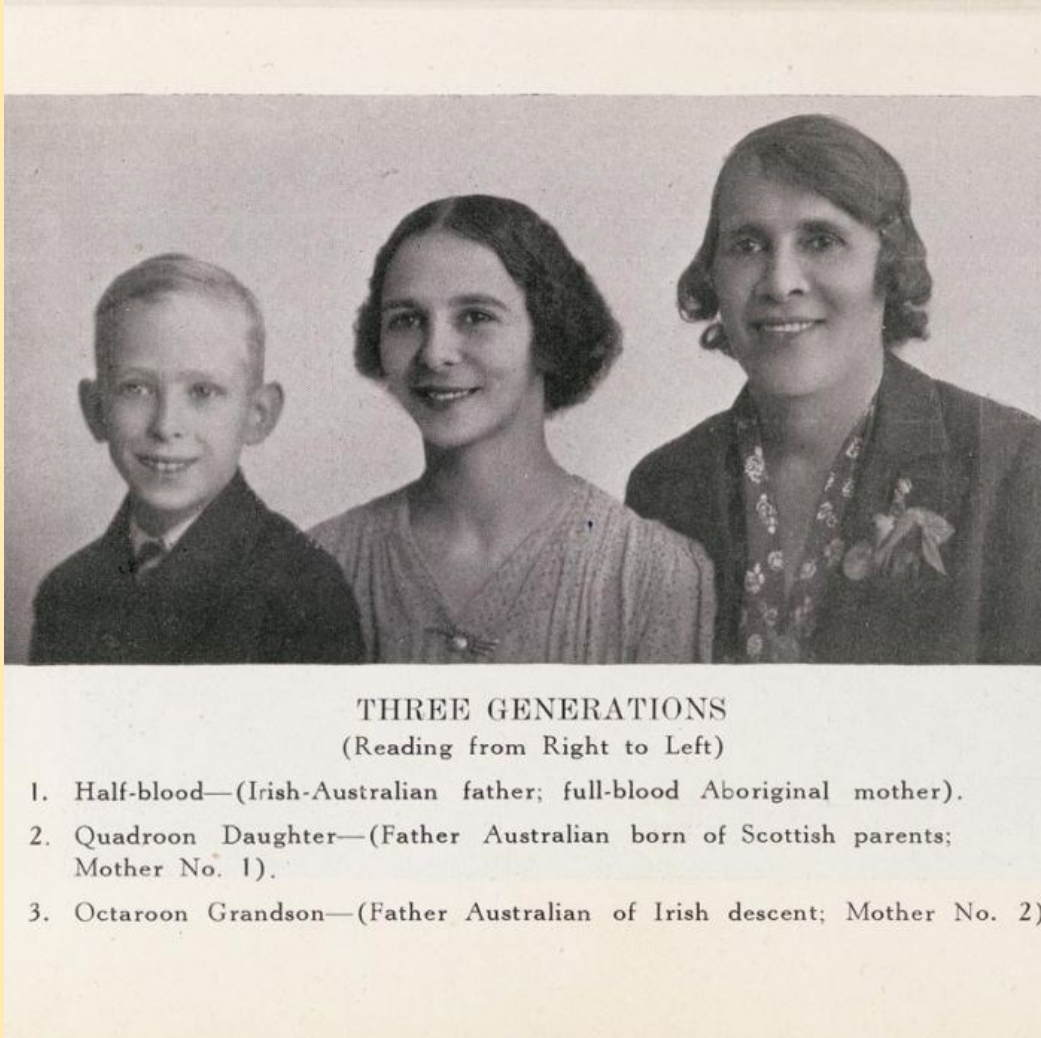
somewhat moral laws i.e. sexual immorality. As for the genocidal campaigns that “changed the face” of “Israel”, it seems that during times of the foreign occupation of the old Holy Land, the desire of its colonizers was to become someone they are not: the Lord’s heritage. As for how this genocide happened, the history of a different race of Indigenous people helps explain how the genocide of ancient Israel was likely to have occurred. The Indigenous peoples who are to be used as an example of ethnic genocide are the Indigenous Australian and Torres Strait Islander (IA&TSI) peoples, who were colonized by the British (white Australians) during the brutal conquest of the IA&TSI peoples homeland of Australia (Rigney, 1998, EB, 2021a).

### HOW INHERITENCE IS LOST – A CHANGE IN RACE

The colonization of the IA&TSI peoples is a story of genocide that begun as early as the year 1788, with the greatest atrocities of IA&TSI colonization being encompassed by the events of the ‘Stolen Generation’ (Rigney, 1998, EB, 2021a). The events of the ‘Stolen Generation’ led to the forced marriage or rather “mating” of Indigenous women to white Australian men in order to “replace” the identity of Australia’s original people with white Australians (British) (Rigney, 1998). The obvious intent of these actions was to produce a “whiter version” of IA&TSI peoples for the purpose of opportunistic convenience in the area of land rights. To elaborate, the events of the ‘Stolen Generation’ involved the forced removal of IA&TSI children from their natural family settings; forcing young IA&TSI girls into “Christian” missions that aimed to “whiten” their mentality, which of course led to the female IA&TSI women being married off to white Australian men (Rigney, 1998).

The purpose of “white” education was to “encourage integration” by preventing IA&TSI peoples learning about their own history, culture and languages, and substituting it with an education based on white Australian (British) history, culture and language (Rigney, 1998). Hence, the acquisition of a “white” education was the standard procedure before a “colonizer marriage”, with the consecutive “whitewashed” marriages eventually resulting in a change of racial appearance (Neville, 1947). The heinous acts of the ‘Stolen generation’ were encouraged for multiple generations, and has resulted in white people with the smallest amount of Indigenous IA&TSI blood claiming the IA&TSI peoples identity, therefore “displacing” those with the truest and greatest claim to IA&TSI peoples heritage. However, the truth is that blood does not lie, and “one drop” does not define the ninety-nine other drops – after all, percentages and proportions are a basic fundamental of mathematics. The image on the next page shows the generational whitening of IA&TSI people, which also indicates that more than enough time has passed to significantly “replace” the bloodline of God’s original people who lived in the land of Israel, as it is clear that only three generations are enough to achieve such a “goal” – which is nothing more than a racist ideology used to “justify” wickedness i.e. choosing to do wrong, but not wanting to own up to one’s own evil choice of actions. To emphasize the severity of the treatment of the IA&TSI peoples, it is worth

mentioning that the practices of the 'Stolen Generation' occurred for approximately 150 years, which was up into the late 1970s, and it continued for so long because white Australians openly considered the IA&TSI peoples as actual plants and animals (Rigney, 1998).

Therefore, within the context of the Lord's inheritance, and the nation of Israel and Jews in general, the same one drop rule applies, but according to the correct fundamentals of mathematics – and not colonizer propaganda. Hence, with little-to-no blood ties to the Ancient House of Israel there is no heritage, as God will not claim what is not His, nor is He deceived by the schemes of mankind.

It should be quite clear by now that He led the Lost Tribes of Israel to the Biafran land a long time ago to preserve a remnant, or rather a “chosen remnant” (Isaiah 11) of His people, who are the Igbo and Biafran people who are descended from the 12 Lost Tribes of Israel (Elekwachi, 2020b). Hence, just as Isaac (Isiaku) was identified as Abraham’s (Abiamá) true son and heir and Ishmael was not, the Igbo/Biafrans are identified as the Lord’s inheritance, and Israel is not. This same sentiment is reflected by the inheritance of the Abrahamic covenant by Jacob’s (Yako/Jiko-obi) descendants, and not Esau’s descendants (Edom). This should be of no surprise, as these facts are easily verifiable through years of research, and are further supported by Biblical evidence. Therefore, Israeli and Jewish people of any variety should not take offence, as the Lord is known to seek that which is lost, and that is His heritage: The Lost Tribes of Israel. However, just because Israel is not the Lord’s inheritance, it does not mean that you are not His people – after all a bond with God is first based on faith, and so, if you truly believe in Him then He will always be your God. Ethiopian Jews, also fall into the same category as Israeli Jews because the only blood that ties them to The Ancient House of Israel is through one person, one very ancient person, King Solomon, but it is also very clear that Ethiopian Jews are Ethiopians who practice Judaism (Spector, 2005).

It is also of further note that the Bible mentions “Jews who are not Jews”, who are directly referenced to have a connection with the synagogue of Satan. The reason for the reference “Synagogue of Satan” is most likely associated with a combination of factors such as (1) the worship of other gods among Jewish people (2) failing to properly acknowledge and/or denying the true heritage of God’s people (Igbo’s and Biafrans) and (3) continuing to practice Judaism, which denies the Name and significance of Christ (not acknowledging the Son of the Lord, the Most High God). In brief, Judaism is essentially an outdated form of religion that does not lead to salvation (receiving the Holy Spirit), and therefore it was made obsolete by the Lord Himself through the introduction of the New Covenant:

- **Hebrews 8:6**—<sup>6</sup>*But now he has obtained a more excellent ministry, by so much as he is also the mediator of a better covenant, which on better promises has been given as law.*
  - **NOTE:** “He” refers to the Lord, Jesus Christ
- **Hebrews 8:13** - <sup>13</sup>*In that he says, “A new covenant”, he has made the first old. But that which is becoming old and grows aged is near to vanishing away*
- **Acts 3:19-22**—<sup>19</sup>*Repent therefore, and turn again, that your sins may be blotted out, so that there may come times of refreshing from the presence of the Lord,* <sup>20</sup>*and that he may send Christ Jesus, who was ordained for you before,* <sup>21</sup>*whom heaven must receive until the times of restoration of all things, which God spoke long ago by the mouth of his holy*

prophets. <sup>22</sup>For Moses indeed said to the fathers, ‘The Lord God will raise up a prophet for you from among your brothers, like me. You shall listen to him in all things whatever he says to you.

- **NOTE:** Original prophecy about Christ is mentioned in Deuteronomy 18:15,19).
  - **Deuteronomy 18:15, 19** - <sup>15</sup>Yahweh your God will raise up to you a prophet from among you, of your brothers, like me. You shall listen to him...<sup>18</sup> I will raise them up a prophet from among their brothers, like you. I will put my words in his mouth, and he shall speak to them all that I shall command him.

It is common knowledge that those who practice Judaism do not acknowledge Jesus Christ, as the Son of the Lord, the Most High God i.e. God in His human form. However, there is knowledge and references made to the Lord Jesus Christ in the Torah. So, it leads to the question of why Judaism is continually practice despite this knowledge being available for centuries? Therefore, it is without a doubt that Jewish people are those identified as “the Synagogue of Satan”, because it appears that Judaism denies the Name of the man who is the God of Abraham, Isaac and Jacob – which is a rejection of their own God’s Truth and Word.

- **Revelation 2:9** - *“I know your works, oppression, and your poverty (but you are rich), and the blasphemy of those who say they are Jews, and they are not, but are a synagogue of Satan.*
  - **NOTE:** To deny the Lord’s Name i.e. Jesus is not real or not God is blasphemy, especially towards those who claim to worship the God of Abraham, Isaac and Jacob: Jesus is simply God in His human form.
- **Revelation 3:9** - <sup>8</sup> *“I know your works (behold, I have set before you an open door, which no one can shut), that you have a little power, and kept my word, and didn’t deny my name. Behold, I give some of the synagogue of Satan, of those who say they are Jews, and they are not, but lie—behold, I will make them to come and worship before your feet, and to know that I have loved you.*
  - **NOTE:** “Behold, I give some of the synagogue of Satan” means that the Lord, the Most High God ordained to save many Jewish people through the work (deeds) that I have done, and will do.

The denial of Jesus Christ by Jewish people is hopefully one of unbelief and ignorance (Mark 9:24), as it should be pointed out that denying the Name and power of Christ, and therefore, the Lord, the Most High God (Elohim), is common practice among people who do not believe in God at all, such as atheists, Muslims or devoted Satanists. However, the Jewish are known to be a people

of tradition, zeal and faith, and so, it is likely that many Jewish people will be saved (as it is written). Lastly, it is of note that the Scripture Galatians 6:11-12 indicates that the New Covenant is not preached among Jewish people for the fear of persecution. Apparently, the long-established Jewish elders or scholars, and perhaps other Christian scholars (The Gospel of Thomas) knew the Truth about Judaism and the New Covenant, but chose to hide their knowledge instead of spreading it due to a lack of courage:

- **Galatians 6:11-12** - <sup>11</sup>See with what large letters I write to you with my own hand. <sup>12</sup>As many as desire to make a good impression in the flesh compel you to be circumcised; just so they may not be persecuted for the cross of Christ.

The “cross of Christ” is basically Christian persecution, in which its reality has been explained in many articles and books from The VMFCP (Elekwachi, 2021b, Elekwachi, 2021c, Elekwachi, 2021a, Elekwachi, 2021d, Elekwachi, 2020a). For further context and comfort, there is one particular occurrence of severe persecution that is also known as the “fiery trial” or “hour of trial” (1 Peter 4:12, Revelation 3:10), the “abomination of desolation” (Matthew 24:15), a “flood” (Revelation 12:15), and the trouble (disturbance) from the Gospel of Thomas. However, it has been made clear that the severe “cross of Christ” has already happened i.e. it was “once and done” and cannot be repeated again (Elekwachi, 2021b, Elekwachi, 2021c, Elekwachi, 2021a, Elekwachi, 2021d). Obviously, there is likely to be Christian persecution in the future by the unrepentant, but it would be of a much lesser magnitude due to (1) God’s will (2) increased knowledge of the Truth i.e. Isaiah 11:9 is already in its beginning through all my work i.e. The VMFCP (3) an increased number of Christian people and (4) the results of the final effort for salvation, which will without a doubt involve reformed churches that are able to pastorally support large numbers of people.

### **BIBLICAL EVIDENCE OF ANCIENT ISRAELITE GENOCIDE**

Naturally, there is biblical evidence to support that the Ancient House of Israel, who were the people of God’s heritage that lived in the land of Israel in ancient times, were subject to genocide in the same manner that actually somewhat corresponds with the events of the colonization of Australia.

- (1) Following the rejection of Jesus Christ by His own people in the Southern Kingdom of Israel, Judah; His suffering, persecution and crucifixion, the Lord appointed divine judgement for the innocent blood and sins committed by His heritage against His servants and prophets – but not just for that generation, but generations past. As His people continually refused to do what was right, despite the fact that they knew right from wrong i.e. breaking His covenant and disregarding His commandments:

- *Matthew 23: 33- 37* -<sup>33</sup> You serpents, you offspring of vipers, how will you escape the judgment of Gehenna? <sup>34</sup>Therefore, behold, I send to you prophets, wise men, and scribes. Some of them you will kill and crucify; and some of them you will scourge in your synagogues and persecute from city to city, <sup>35</sup>that on you may come all the righteous blood shed on the earth, from the blood of righteous Abel to the blood of Zachariah son of Barachiah, whom you killed between the sanctuary and the altar.<sup>36</sup> Most certainly I tell you, all these things will come upon this generation.<sup>37</sup> “Jerusalem, Jerusalem, who kills the prophets and stones those who are sent to her! How often I would have gathered your children together, even as a hen gathers her chicks under her wings, and you would not! <sup>38</sup>Behold, your house is left to you desolate.

(2) The divine judgment of the Southern Kingdom of Judah, of which Jerusalem was the capital, is believed to have occurred after the first coming of Christ, which fulfills the prophecy that the Lord spoke of in Matthew 23:33-37. Notably, the divine judgement of Judah also coincides with a prophetic event from the Book of Daniel, which reflects the colonization, and occupation of Judah (and Israel) by a foreign people, and the genocide of God’s people who lived there:

- *Daniel 11: 40-45* -<sup>40</sup> “At the time of the end the king of the south will contend with him; and the king of the north will come against him like a whirlwind, with chariots, with horsemen, and with many ships. He will enter into the countries, and will overflow and pass through. <sup>41</sup>He will enter also into the glorious land, and many countries will be overthrown; but these will be delivered out of his hand: Edom, Moab, and the chief of the children of Ammon. <sup>42</sup>He will also stretch out his hand on the countries. The land of Egypt won’t escape. <sup>43</sup>But he will have power over the treasures of gold and of silver, and over all the precious things of Egypt. The Libyans and the Ethiopians will be at his steps. <sup>44</sup>But news out of the east and out of the north will trouble him; and he will go out with great fury to destroy and utterly to sweep away many. <sup>45</sup>He will plant the tents of his palace between the sea and the glorious holy mountain; yet he will come to his end, and no one will help him.

- **NOTE:** It is unclear and unknown to me who the Northern King was, but perhaps further research and time will tell. Furthermore, the word “sea” most likely reads a “seas”, as in other Biblical translations (The PBIT Tip 1, understanding) (Elekwachi, 2021b).

A) The glorious land refers to the land and nation called Israel, which is located between four seas: the Red Sea (not pictured, but is linked to the Gulf of Aqaba at the most Southern

part of present day Israel), the Mediterranean sea, the Dead sea and the Sea of galilee (Lake Tiberius).



A map of the land of Israel that shows the four “seas” that surround the land, and Mount Tabor, the “The glorious Holy mountain” (EB, 2008).

- B) “The glorious Holy mountain” most likely refers to Mount Tabor, which was the original site of the Lord’s transfiguration i.e. where the Lord’s appearance was transformed when He spoke to Moses and Elijah before His crucifixion (HBP, 2014). The transfiguration most likely indicated a spiritual encounter i.e. the convergence of the spiritual and physical worlds, which allowed for the visible communication between the spirits of Moses, Elijah, and the Lord. The visibility of the encounter then enabled the Lord’s disciples to make a record of it for the Holy Bible.
- C) To set up a “tent” is akin to colonization and the occupation of a land, much like how the British invaded Australia and set up their own nation in the midst of the IA&TSI peoples homeland (Rigney, 1998). Or how the “killer herdsmen” of Miyetti Allah Cattle Breeders Association of Nigeria (MACBAN) try to occupy and live in the lands, forests and farms of

Biafrans and the Yoruba (Oduduwa) with their multitude of cows (Vanguard, 2020, Ezemenaka and Ekumaoko, 2018, TGN, 2021). To make it clear, this prophecy from the Book of Daniel is not being repeated. This is expressed because it is known that certain people have promoted the unlawful use of the Biblical Scriptures to try and “justify” crimes against humanity, particularly during colonization. In the case of the colonization of the IA&TSI peoples by the British, their “methods and choices” were based on racist propaganda and beliefs i.e. *“Darker people are a sub-human lesser species, therefore if we do bad things to them it does not matter, it is good and right in the eyes of God”*. To be clear this is a non-verbatim summary of the type of racist beliefs that were used to “justify” the colonization of Australia, and is reportedly the “norm” to this day, which is also expressed based on experience (Moses, 2004, Coram, 2007, Schulz, 2020).

On the next page there are screenshots taken from the, ‘*Critical Race Theory (CRT) and Critical Whiteness Studies (CWS)*’ lecture slides for the core topic, ‘*EDUC2420/9400: Teaching Indigenous Australian Students/GE*’, which I completed during my final semester of my Master of Teaching Degree (Secondary) at Flinders University in 2020 (Schulz, 2020). The lecture’s screenshots reflect Australia’s views on race i.e. it appears that some things never change. Hence, it remains that not even over 100’s of years has been enough for Australian’s to accept that racism is wrong. Therefore, the question remains how much time is enough? And the answer is simply choose to accept or reject racism, because time is not a factor, it is a mere subject of choice because racism is expressed in words and actions. Therefore, the next logical question is, are racists unable to control what they say and do? The answer is yes, and so, there is no excuse for racism except wickedness. Overall, the lecture slides reveal that despite Australia’s “reconciliation” or “sorry” efforts, which appear to be empty phrases used to “convey” an apology for their actions against the IA&TSI peoples (or other people), but is typically nothing more than a façade that says “*we are racist, but at least we did something that makes us not look like bad people*”. More so, it should be made clear that white Australian’s are not the only offenders in the area of racism, all Australians are, for example, I have experienced racism from Asian-Australians i.e. suggesting that black people are dirty (this is common among white Australians too); Indian-Australians i.e. an Indian person who was darker than me actually had the nerve to call me a “negro” (a racial slur/insult that means “black”); and even Indigenous Australians i.e. an Indigenous woman said to me in a derogatory manner that she was glad that she wasn’t African. There are many more examples that I could express, but these are just some of them, and therefore, in such times people need to seriously “look in the mirror” (James 1:23).



In Australia today, 'racism' is not a departure from the norm, it is the norm.

**Racism is normal**

**WHAT IS 'RACISM'?**

Most Australians have a fairly simple understanding of racism that either relegates it to the past ...

These screenshots convey white Australia's attitude to racism i.e. "we know it's wrong, but who cares". The image of the racist gang of white Australians is of a past incident known as the Cronulla riots, where white Australian men (and presumably some women) decided to have a "Leb and Wog bashing day" (Baker, 2020), which means that white Australian people actually planned and carried out a non-sensical racial campaign against middle-eastern, Italian or Greek people because?... (Baker, 2020). Hence, on that day anyone who fit the racial appearance of a "Leb or Wog" would have been attacked by a gang of Australian white people.

**A HISTORY OF THE PRESENT: 'RACE'**

- White Europeans not only brought with them new diseases and commodities, they also brought 'racial' ideas and attitudes that had been developed over centuries;
- Ideas about race essentially denied the very humanity of Indigenous peoples who were considered in the dominant imagination to be "wild animals, vermin, scarcely human, hideous to humanity, loathsome, and a nuisance [thus] they were fair game for white 'sportsmen'" and massacres and organised killings on the frontier resulted in the termination of tens of thousands of Aboriginal people (Curthoys & Docker 2002, p. 23);

**A HISTORY OF THE PRESENT: 'RACE'**

- Underpinning these over racist acts was belief in the theory of a Great Chain of Being which ranked racial groups from primates through lower 'coloured' races to Europeans and up to the Almighty;
- The upshot of this thinking – which had garnered the scientific stamp of 'truth' – was that, despite their rich and intricate knowledge of their lands, and complex social, educational and spiritual systems, Indigenous peoples were thought (by Europeans) to be at the very bottom of a pre-determined and fixed social hierarchy.
- Wolfe (cited in Moodie 2018, p. 33) points out that the key element here was 'territory'; 'the primary motivation for elimination [...] was] access to territory. Territoriality is settler colonialism's specific, irreducible element.' **Think today about the mining industry, pastoral leases ... there remain many ways, connected to territory, by which claims to native title can be extinguished ... and racial hierarchy kept firmly in place, but ...**

These screenshots convey the British views on race, a social hierarchy where the British (Anglo-Saxons) sit on top, and everyone else beneath them. This belief stems from "science", such as Darwinian theory (Darwinism) which are the foundation of the British views on race. The known British view on race is that is that other and/or darker peoples are likened to animals, or are actually animals i.e. an absence of difference (Jeynes, 2011). It is of note that Charles Darwin, the creator of Darwinism, was a British (Anglo-Saxon) man. Hence, it was intentionally written by me in 'Calling: Special Edition' (pg.62) that, "Racism is based on a man-made social hierarchy of the worlds different races i.e. it supports human inequality. However, in Christianity all are considered equal, because all are one in Christ (Galatians 3:28). Therefore, because a racist chooses not to accept the people of another race as equal [i.e. not sub-human or lesser], they are unable to enter the New Covenant."

### FACTOR NUMBER 3 - LAND HERITAGE

The third and final factor that determines the Lord's inheritance makes it clear whom God has chosen and why – blood alone is not enough. It is known that the Biafrans and the Igbo people were subject to the trans-Atlantic slave trade, which resulted in the removal or uprooting of many of its people from its heritage (Chambers, 1997). Therefore, this means that the Biafran people of the transatlantic slave trade such as Barbadians, Jamaicans, and African Americans have long become their own people, which means that they were cut off from the people of the chosen and righteous branch (the Igbo and Biafrans). This is made exceptionally clear by the adoption of a new name for their peoples; the establishment of their own cultures; and another existing nation actually being their homeland. Hence, there are “branches” of the Lord's people who have blood ties to the Igbo and Biafrans – however, the holy land of Biafra is not their home, nor is its culture their culture, or their languages its indigenous languages: and therefore, they have no claim in the Lord's inheritance simply because they are not Biafran. But once again, just because such people are not God's inheritance, it does not mean that you are not His people – after all a bond with God is first based on faith i.e. if you truly believe in Him then He will always be your God.

Therefore, let it be known, it is Biafrans who have suffered and fought for their home for over 50 years, and so, it is Biafrans who will enjoy the fullest blessings that God will bestow upon His inheritance and Holy Land. Hence, never ever will God's own people be displaced from their own land, especially not by “killer herdsman” or anyone who are like them. The Lord will establish Biafra for those of His faithful remnant, and the dispersed of His heritage, such as myself, who are indigenous Biafrans living in different nations i.e. the Lord's wolves, leopards, goats, calves, lions and cobras are metaphors for people of Biafran heritage who are also citizens of other countries (Isaiah 11). Therefore, let it be known once again that it is the will of God to restore the fortunes of His people, but it is simply a matter of time, and so, despite the troubles that Biafra has faced and is currently facing, their Lord, God and heavenly Father, Chuckwuokikeabimá has not abandoned them (Psalm 94) – He will have mercy on His people, but His people must learn to respect their God.

### ARTICLE PINPOINT

The Igbo and Biafran people are descended from the Ancient House of Israel through direct Abrahamic patriarchal descent, which is Biblically and culturally valid. However, Israel's use of the “matrilineal principle” to claim descent from the Ancient House of Israel is not, and it was never actually accepted by the Lord, the Most High God. This was determined based on the fact that (1) patriarchal heritage is the normal standard for legitimate descent (2) The Lord, the Most High God, disinherited present day Israel (and its peoples, including Ethiopian Jews) centuries ago (3) strong blood ties to the Ancient House of Israel is the sole determiner of being granted the Abrahamic-

Isaac-Jacobic covenants i.e. the teaching of commandments and the understanding of Biblical revelations and mysteries, and (4) the Lord, the Most High God, planned and acted a long time ago to preserve the 12 Lost Tribes of Israel in the Holy Land of “Arzareth”, which is the spiritual title of Biafra. Hence, the Biafran land is the future home of the Lord’s Holy city, the “new Jerusalem” (not the actual name), and it belongs to the people of His inheritance – the Igbo’s and Biafrans.

Although Christians are “one in Christ”, God will always have a “special family tie” to His own race and “chosen people”, which results in them inheriting the promises, covenants, and the God ordained anointing to give the law (commandments) (Romans 9:1-8). After all, it has always been known that blood is thicker than water. Therefore, do not forget that for an Igbo/Biafran Christian, in addition to culture the bond to their God is 3-fold i.e. BLOOD: significant blood ties to the Ancient House of Israel through direct patriarchal descent (race), “drinking from the cup of the Lord” (Elekwachi, 2020c); and WATER, receiving the Holy Spirit. Therefore, the reality is that for people of different heritage, the bond to their God is 2-fold i.e. BLOOD, “drinking from the cup of the Lord” (Elekwachi, 2020c); and WATER, receiving the Holy Spirit. The truth is that before I knew of the Igbo/Biafran people’s ties to the Ancient House of Israel, I had absolutely no problem or issue not belonging to “God’s heritage”. This means that I was completely fine with a “gentile” bond, and therefore, I also had no issue believing in or worshipping “another people’s God” i.e. race nor ethnicity had no effect or influence on my choice of faith. Therefore, the logical conclusion is that (1) I am not racist and (2) I am not jealous/envious, and therefore it is evidence that my faith in Jesus Christ never depended on the race of my God. Instead it was His commandments, which informed my way of life and, the Truth that always meant the most to me. Therefore, if people have an issue with the Truth, then it simply indicates that such people are not “good fish” (Matthew 4:19).
