ARTICLE SUMMARY

The article, *'The signs of the times: the mark of the beast is a metaphor'*, highlighted that Babylon, which is the spiritual title of England, and its daughter nation of Australia are responsible for causing and triggering the "end of the age"; and therefore the divine judgement of the entire world. This article focuses on describing the consequences of Babylon's use of demonic forces in the persecution of Christians, which are known as the four horses or horsemen of the apocalypse (Revelation 6). Hence, this article further elaborates on the revelations associated with the "end of the age" with a bit more depth in relation to (1) why disturbing events are continually happening (2) the general laws of divine providence and divine failure (3) the general laws of divine judgement and (4) the general laws of death. The need to explain these Biblical and now real-world concepts is the consequence of Babylon's pre-meditated evil that must have been based on the assumption that demonic and divine forces can be controlled by human beings. This assumption is wrong because this article proves that facing the power of 'Death' is not equal to dying – and so, this is a testament to the Lord's hatred of Babylon's attempt at planned mass human sacrifice. Therefore, it remains that I would not have worked out these things and lived to record them for public consumption unless the Lord, the Most High God, wanted to expose those who are solely and entirely responsible: Babylon.

THE FOUR HORSEMEN OF THE APOCALYPSE

To those untrained in the arts of Biblical interpretation, Biblical wisdom, knowledge and understanding, it may appear that the Lord, the Most High God i.e. Jesus Christ (the Lamb of God) is releasing chaos into the earth via the “four horsemen of the apocalypse” (Revelation 6) – but that is not quite the truth. To be clear it is the Babylonian occult who chose to release powerful demonic forces into the world, which is represented as the unsealing of the seven seals by Jesus Christ, but that is merely another metaphor to be explained later in this section. In simple terms, the release of the four horsemen is equivalent to the opening of ‘Pandora’s Box’, and so, Babylon and the Satanic league of nations literally unleashed hell on earth, as demonstrated by the growing disturbances across the world, whether it relates to people or nature. This reality is reflected by global, but quite recent tribulations such as COVID-19, the reemergence of Ebola virus, economic instability, natural disasters i.e. earthquakes, floods, famine; increased food prices, especially in third world countries; the succeeding of nations, and the resulting hostilities by those who seek to control them i.e. Biafra, and the Tigray; or civil unrest due to government instability i.e. Myanmar (BBC, 2020c, BBC, 2020b, BBC, 2020a, Gilliland, 2020, NBC, 2020, Vanguard, 2020b, Mashal and Kumar, 2021, Alami, 2021). The concept of spiritual actions effecting the natural world, whether it is the balance of nature or the rate of death, is described by the Lord in Matthew chapter 18.

- **Matthew 18:18** – *“¹⁸ Most certainly I tell you, whatever things you bind on earth will have been bound in heaven, and whatever things you release on earth will have been released in heaven.”*
 - **NOTE:** The word ‘heaven’ reads as ‘spirit’, and so, the scripture means that spiritual actions such as sorcery have an effect on the natural world. Therefore, depending on how powerful a “force” is or how many people “wield” it, the effect is likely to be proportional.

Based on the scripture Matthew 18:18, the logical conclusion is that it’s a terrible idea to use sorcery for the purpose of acquiring and “wielding” the power to maintain “dominion” and exert a more forceful mode of world-wide control over individual people, governments, authorities and nations (Revelation 13:7-10). This exact course of action was committed by the Babylonian occult, who most likely belong to the ‘church in Thyatira’ and the ‘church in Pergamum’. Hence, the severe consequences faced by the city that is “the great prostitute” (London), Babylonian nations, and the unrepentant with TMOTB (Revelation 8, 9 16, 17 and 18). The reason why this knowledge is known to me is made clear in the next section of this article, ‘Facing ‘Death’ is not equal to dying’. However, before that the opening of the seals in Revelation 6 needs to be explained so that people are able to understand that the Bible is also a book of mysteries. As a form of cypher or “secret code”, the

Bible's mysteries actually require the gifts of wisdom, understanding, knowledge, developed Biblical literacy and real-life experience to make the connection between interconnecting Biblical prophecies and what it relates to in real life. Hence, it is through the revealing of such mysteries that the almighty power and true nature of the Lord of lords, God of gods, and King of kings can be understood. The opening of the seals is a reference to The Lord Jesus Christ's authority over all that happens in heaven and earth, whether it is the past, present or future, and therefore, when certain events actually happen and its outcomes, but it remains that humans are still entitled to free-will (bad things happen because people choose to do bad things). More so, within human free-will and the human experience, the Lord, the Most High God, is also able to intervene in the lives of people without them recognizing it, which is a phenomenon that can be called 'divine providence' or 'divine failure'.

Divine providence is equivalent to real-life "plot armor" that comes from the Lord, the Most High God, who is the helper of Christians, which is conveyed by Scriptures like Revelation 3:8, *"I know your works (behold, I have set before you an open door, which no one can shut), that you have a little power, and kept my word, and didn't deny my name."* To be clear divine providence is the blessing of the righteous, which is conveyed by the Book of Ruth, for example, it was the divine providence of the Lord, the Most High God, that led Naomi and Ruth through lack, sadness, struggle, toil and eventually greater happiness and contentment; yet they never saw or spoke to God, they simply believed in Him. Therefore, even in the face of the four horsemen of the apocalypse, the Lord, the Most High God, is the helper of those who they were initially used against (Christians). Alternatively, there is also Biblical evidence of 'divine failure', which is reserved for those who are "in the wrong" ("bad") or the enemies of Christians (1 King 22:1-37). Divine failure is the result of Jesus' holding dominion over other gods such as Satan, demons, and all of mankind; and that is because He is the God of gods, Lord of lords and King of kings. Therefore, the events of Revelation 6:1-8 and Isaiah 28 can be considered Babylon's act of divine failure, for it was by (1) Satanic worship (2) Satanic power (3) injustice (4) wickedness (5) deceit and (6) short-sightedness that Babylon and the Satanic league of nations released and wielded the power of the four horsemen of the apocalypse in the attempt to maintain its dominion; take God's kingdom by actual "force"; and sacrifice the lives of other people and nations to pay the "price" of such efforts, for the sake of their own future and hope (which they ruined).

Below is a brief explanation of the effects linked to the demonic forces, known as the four horses of the apocalypse, from Revelation 6 that were summoned and used by Babylon in its quest for "more power":

- **Revelation 6: 1-2** - ¹I saw that the Lamb opened one of the seven seals, and I heard one of the four living creatures saying, as with a voice of thunder, “Come and see!” ²Then a white horse appeared, and he who sat on it had a bow. A crown was given to him, and he came out conquering, and to conquer.
 - **NOTE:** The white horse is most likely linked to a demonic force that influences the strength/control of a dominion, whether it is certain people’s dominion such as “kings” or nations and its people, for example, Babylon and the beast with its multitude of crowns (Revelation 17). This war horse/rider is what permits Babylon and “the world”, who are those with TMOTB to hold temporary authority over Christians (Revelation 13). The article pinpoint clarifies why Jesus also has a white horse.

- **Revelation 6: 3-4** - ³When he opened the second seal, I heard the second living creature saying, “Come!” ⁴Another came out: a red horse. To him who sat on it was given power to take peace from the earth, and that they should kill one another. There was given to him a great sword.
 - **NOTE:** The red horse is most likely a demonic force linked to increased aggression and violence between people, and therefore attempts and acts of violence and murder. Therefore, this is most likely “the power of the sword” that resulted in the death of Christians who were given over to it (Revelation 13:10). In this case, it is most likely that some of the Christians who were “given over to the sword” held knowledge of the Truth i.e. people who had already received the Holy Spirit (Revelation 6:9).

- **Revelation 6: 5-6** - ⁵When he opened the third seal, I heard the third living creature saying, “Come and see!” And behold, a black horse, and he who sat on it had a balance in his hand. ⁶I heard a voice in the middle of the four living creatures saying, “A choenix of wheat for a denarius, and three choenix of barley for a denarius! Don’t damage the oil and the wine!”
 - **NOTE:** The black horse is most likely a demonic force linked to global economic and environmental troubles, and therefore a general increase in the cost and “quality” of living. However, in its earliest stages its effect is most damaging to third-world countries, where the price of common food staples is known to exceed people’s salary. For example, it is common knowledge that a bag of rice, in the soon to be abolished country of Nigeria, exceeds the wages of many of its citizens, and so, if not for its own people’s resourcefulness (farming) and generous family members than many people would have perished for lack of food. The exact meaning of “oil

and wine” is unlikely to refer to crude oil and wine is not likely to refer to alcoholic beverages. It is more likely that ‘oil and wine’ is associated with repentance and salvation (a reference to Christian matters being associated with food and drink) i.e. the current circumstances has cheapened the way to salvation, and all the knowledge needed to be saved is basically free (cheap). As for the ‘balance’ or scales in the hands of the rider, this would represent a disruption in the balance of nature, and therefore a more rapid increase in climate change and environmental disturbances such as floods, droughts, fires and earthquakes. Therefore, it appears that the environmental disturbances will eventually have a direct effect on the global food and water supply, which is directly linked to the economy. It is most likely that this demon was summoned with the ‘pale horse’ in order to increase the likelihood of death, particularly among people living in third-world countries.

- **Revelation 6:7-8** - ⁷When he opened the fourth seal, I heard the fourth living creature saying, “Come and see!” ⁸And behold, a pale horse, and the name of he who sat on it was Death. Hades followed with him. Authority over one fourth of the earth, to kill with the sword, with famine, with death, and by the wild animals of the earth was given to him.
 - **NOTE:** The pale horse and its rider ‘Death’ who is followed by ‘Hades’ reveals that those who fall to the power of death are condemned to hell (Hades). Based on the Wisdom of Solomon 17, it appears that Babylon intentionally summoned ‘Death’ and ‘Hades’ because they wanted the power to choose who dies and condemn other souls to hell in such times i.e. not themselves. Therefore, it is to be remembered that Babylon had Satanic foreknowledge of these times, and so, in hindsight it appears that they were trying to “play God” i.e. trying to change the law and the times, which is referenced in Daniel 7:25 (Elekwachi, 2021e). Furthermore, it is most likely that the ‘black horse’ and ‘pale horse’ are “paired”, meaning that they were most likely summoned at the same time i.e. economic trouble and an increased death rate is directly linked to the consequences of COVID-19. This is elaborated upon later in the article.

To conclude, people need to understand that spiritual matters greatly influence the balance of the world and nature, and so, in the case of sorcery, people must also consider the consequences to themselves, other people and the environment – not just locally, but globally. More so, it is already known that TMOTB is not only an Australian issue because (1) it is written that it is a global issue i.e. the Biblical prophecy is true (Revelation 18:7-8) and (2) I have travelled overseas during the “end of the age” i.e. America (multiple times) and Indonesia. Therefore, what was originally a Christian issue, of which there are few, has become a much greater and broader problem, and that

is because each and every person and nation has to face the consequences of Babylon's actions. In all truth there is only one solution: Christianity, as nothing else can break the oath that ties people to TMOTB. Therefore, people have to learn to face life because circumstances are not always ideal, which was a lesson learnt when I had no choice but to continually face the power of 'Death'.

FACING 'DEATH' IS NOT EQUAL TO DYING

If it is not obvious by now that The Lord, the Most High God, never planned to let me die, which is the logical assumption based on the fact that death is not an option for whoever underwent the "fiery trial" (1 Peter 4:12) i.e. me. This may appear confusing since the Scripture, Revelation 12:11, suggests otherwise, but all that is required is a contextual explanation of the Scripture which provides the true meaning of its interpretation:

- **Revelation 12:11** - ¹¹ *They overcame him because of the Lamb's blood, and because of the word of their testimony. They didn't love their life, even to death.*
 - **NOTE:** It is believed that the article '*The signs of the times: the mark of the beast is a metaphor*', which covered my own testimony and my witness testimonies of the 'church in Philadelphia' (5 other faithful Christians that have yet to receive the Holy Spirit due to Mark 6:4) is a reference to 'they', and if not, it may also refer to other Christian testimonies that have been put forward that I do not know of, or testimonies that will be put forward by those of the faithful Christian remnant in the future.

To begin my explanation of defying death, it should be made clear that: I am an individual who has received the Holy Spirit, and has therefore entered the New Covenant. This means that I hold a key position within the Body of Christ (Scribe), and I am someone that the Lord, the Most High God describes as a pillar within His House (Revelation 3:7-13). Secondly, I am classified as a Christian in captivity, which means that it was never in God's plan to "give me over to the power of the sword" (die). Based on the combination of the abovementioned Biblical evidence-based facts the logical conclusion is that I cannot be killed, and that is because the Bible literally says that I have not been ordained to die. The most obvious reason for this logical conclusion is that I must be essential to the Lord's plans during the "end of the age". This is no real revelation because it appears that the "fiery trial" was used as an opportune high intensity Scribe preparation course, for the sake of those who will be saved through my work and endeavors. Therefore, to my foes let this be clear: I am ineligible for human sacrifice and so are the faithful Christians in captivity, and that is because we have no "fees" to pay, nor are we willing to pay anyone else's "fees". For clarities sake, "fees" is a term used to describe the use of human lives (blood) to pay a spiritual blood debt incurred through sin/evil/wrongdoing. This is expressed because the article, '*The signs of the times: the*

mark of the beast is a metaphor, made it clear that Babylon's actions were undertaken to "trade lives" with Christians in the hope of escaping the mass death that was most likely revealed to them through Satanic vision/divination, which they acted on and therefore caused their deaths. The Scriptures make it clear that some people's blood is more expensive than others, for example, righteous blood; but the truth is that not even Jesus Christ's priceless blood was spilt for the wicked, and so, my moral conscience is simply Christ-like, but of course it does not exceed that of the Lord, the Most High God's (John 17: 6-9, John 13:16). It is unclear whether Babylon is trying to use human sacrifice to pay its "fees" for centuries of sins, current sins, or is also paying "fees" for summoning the demons known as "the four horsemen of the apocalypse". After all is it not common knowledge that power exacts a "price", and when you deal in the "dark arts" then human sacrifice is the normal "currency". However, it was made clear in the article, *'The signs of the times: the mark of the beast is a metaphor'*, that Babylon's planned act of mass human sacrifice against faithful Christians has already backfired on those who "wielded" its power, and by natural extension anyone who is "guilty", and therefore "worthy of death". The consequences of the four horsemen of the apocalypse backfiring were not at the expense of Babylonians alone, but to each and every other people and nation across the world, who they purposefully drew into their mess using TMOTB.

HOW BABYLON AND ITS ALLIES HIDES HUMAN SACRIFICE

The Scripture, Revelation 6:7-8, will be used to elaborate upon how those in power try to "hide" mass human sacrifice. The "beasts" or "wild animals" mentioned in Revelation 6:7-8 are metaphors for different people i.e. ravens, kites, dogs, vultures, sheep, rams, lambs, wolves, cows, leopards, goats and calves. Therefore, when its known that there is a large "blood debt" to pay for peoples own choice of actions, it is only natural that a covert "battle royale" or "culling" would erupt among the guilty who would try to ensure their survival by eliminating other people first (Revelation 6:7-8). Hence, people should now understand that some things are purposefully "released", incited or "put in place" because there is an agenda to "hide" mass human sacrifice. For example, in the case of my own people, the Igbo and Biafrans, it is known that the murderous jihadist "killer herdsmen" and the Nigerian Armed Forces are not killing people or provoking Eastern Security Network (ESN) for no reason. The "killer herdsmen" and Nigerian Armed Forces are sent by the Nigerian Government for a reason: Babylon is trying to pay their "fees" with the lives of Biafran civilians, and therefore, Buhari's Nigerian Federal Government, The Nigerian Armed Forces and Miyetti Allah's "killer herdsmen" are simply Babylon's tools used to try and offset their "fees" .(TGN, 2021, Ezemenaka and Ekumaoko, 2018, Vanguard, 2020a, Elekwachi, 2021a). This is why the entire Biafran situation is brutal, cruel, chaotic, and ridiculous: (1) the Nigerian armed forces are killing unarmed Biafran civilians (2) The Nigerian Government knows what's happening, and therefore must be giving orders (3) the Biafran land (and Southern region) is being invaded by

Federal Government permitted “killer herdsmen” with cows (illegal immigrants) (4) Biafran vigilantes (ESN) had to take it upon themselves to defend its own people from the Nigerian Armed Forces and “killer herdsmen”, and (5) the Nigerian Federal Government must be purposefully turning a “blind-eye” to “killer herdsmen” while its “citizens” suffer because of them (Vanguard, 2020a, Ezemenaka and Ekumaoko, 2018, TGN, 2021, Elekwachi, 2021a). Based on the above, the only logical conclusion is that the Nigerian Government was always planning to kill and destroy the Biafran people (attempted genocide). Therefore, it is made clear that the Nigerian Government is trying to provoke a war in Nigeria because it increases the likelihood of death, and therefore the offsetting of Babylonian and its Nigerian allies “fees”. This means that Babylonian “kings” probably told Buhari to instigate war because if Biafran blood is spilt first then it leaves them and their people with better “odds” (but not really). Therefore, although ESN is defending Biafrans, it is my prayer that all-out-war is avoided because it is simply the means by which Babylon is trying to avoid paying their own “fees”.

Therefore, whoever plans, willingly participates in, or carries out acts of human sacrifice, especially for monetary or material benefits, then you should know that the Lord, the Most High God, knows your wickedness and its why He will ensure that ‘Death’ eventually takes you instead. This means that because the entire world is going through a period of divine judgement, people who are judged as “bad” must pay their “fees” and that fee is their own life, rather than someone else’s. The above should make it clear to Babylon that the Holy nation (Biafra) is not in your power despite what is currently happening, and that is because the Lord, the Most High God, will not abandon His heritage (Wisdom of Solomon 17:2, Psalm 94, Psalm 33). Hence, Biafrans will not be defeated, overcome, enslaved or wiped out, and even I am ordained to remain in the ‘land of the living’ until the very day that the Lord, the Most High God, returns to this earth, and the same sentiment extends to those of the ‘Church in Philadelphia’. Therefore, it should now be clear that Babylon and its allies wasted its “one shot” to “change the times and the law” (Daniel 7:25), which was an effort to maintain their dominion by (1) wiping out God’s Heritage (Biafrans) (2) attempting to kill and corrupt the souls of the ‘church in Philadelphia’, who are essentially a small number of people from God’s heritage (less than 7) who are ordained to help save other people and nations (3) attempting to “suppress”, and presumably steal my work in the delusional belief that God would “choose” or “elect” them... and (4) attempting to sacrifice every other people, heritage and nation except their own by using the TMOTB and Corona Virus (COVID-19) to offset their “fees”. It is assumed that Babylonians did not reveal this information to its conspirators, but now that it has been revealed it is only fitting that those who have been deceived realize who they are dealing with: the ‘The House of the Dead’. To be clear, the overall “price” of this terrible mess is the death of a minimum of 25% of “the world’s” population with TMOTB, many of which will obviously be Babylon’s own people; and that is because what they have done is the definition of a crime against humanity.

After all, if Babylon unleashed and made use of the demonic power of ‘Death’, it is obvious that the direct consequence is death amongst the guilty parties, whether it is tomorrow; next week; next month; the following months (Isaiah 28); or when the Lord returns, as it is simply a final lesson for the unrepentant, merciless and wicked to witness the Truth in its final and most defining moments (Elekwachi, 2021a). Therefore, to people of other nations who may read this article – do not forget that Babylon’s actions have affected you as well: (1) economic issues (2) environmental disturbances and (3) your own people have been turned into human sacrifices.

THE COVID-19 COVER UP

In brief, the ‘pale horse’ and its rider, ‘Death’ is a Satanic/demonic force from the pits of hell that causes physical death, whether it is through spontaneous physical death by varying means; an increase in the likelihood of death (immunosuppression, stress, anxiety, fear); the exacerbation (worsening) of an illnesses symptoms; or increasing the spread or “ability to catch” disease. To elaborate on the connection between the ‘pale horse’ and COVID-19, it is believed that COVID-19 was released to provide a “reason” for the eventual number of deaths, that may or may not be COVID-19 related. This is suspected because (1) COVID-19 has a reportedly exhaustive and very broad list of symptoms, which is odd for what was initially a flu like disease (WHO, 2020a) (2) most people recover from COVID-19, with less than approximately 2.5% of people actually dying from the illness (WHO, 2020c) .

An outline of COVID-19 symptoms reported by the World Health Organization, which his described as “not an exhaustive list” (WHO, 2020a). Therefore, the other symptoms of COVID-19 remain unknown, undefined, and therefore very broad.

In direct comparison, Ebola virus disease is more deadly, as its death rate is approximately 50%, and so, how COVID-19 is presented to the public borders on excessive fear-mongering, which makes the situation appear as even more suspect (WHO, 2020b). Therefore, it is suspected that the “kings” of Babylon, the Satanic league of nations, and Babylonians with TMOTB always knew that mass global death would occur due to their actions because (1) the very act of “enforcing” TMOTB would technically render everyone who took the presumed oath to be instantly “worthy of death”, which was done to create alternative targets for ‘Death’, and was therefore a pre-meditated method of offsetting “fees” (Revelation 13:7-8), and (2) the act of encouraging people to accept mammon to persecute or oppress Christians instantly puts them first in line to pay “fees”. Regardless, it is assumed that anyone belonging to the occult receives “benefits”, and so, whether people persecuted Christians or not, such people are more likely to pay “fees”. Therefore, it is most likely that COVID-19 was created and released on purpose because it was Babylon’s original intention to sacrifice other people instead of themselves, which was nothing more than an attempt to offset their great multitude of “fees” (Sudworth, 2020). However, the actions of Babylon must have been based on the assumption that (1) the Babylonian covenant with ‘Death’ would protect them (2) they could always control the power of ‘Death’ and (3) the COVID-19 vaccine would prevent them from dying, however, it has now been made clear that this assumption is incorrect.

Therefore, it stands that COVID-19 is simply an excuse used to “mask” the fact that ‘Death’ backfired on Babylon. This means that the power of ‘Death’, which they summoned and “wielded” is no longer under their control. The reason that ‘Death’ (and ‘Hades’) cannot be controlled by Babylon is because their covenant with them was annulled (cancelled) because the Lord, the Most High God appointed divine intervention (Isaiah 28:14-19, Sheol = Hades). Divine intervention is the standard response to the grievous sins of mankind such as lawlessness, which is mass unrestrained and willing sin, such as the taboo/aru of human sacrifice (Hosea 13:2-3). The result of divine intervention is divine judgement, and it is the outcome of the Lord, the Most High God, commanding lesser gods, such as Satan and the four horsemen of the apocalypse to judge mankind according to actual guilt and innocence. This means that the guilty or “bad” are those who die, and those judged innocent or “good” are the people who live (Psalm 82) (Elekwachi, 2021b). Therefore, it remains that for those with TMOTB, the best shield from death is to simply begin doing God’s commandments.

To elaborate on the links between the Book of Revelation and Isaiah prophecies, a few points require a brief explanation. The “*crown of pride of the drunkards of Ephraim*” (Isaiah 28:1) is whoever holds dominion over Christians in this time, which is Babylon, its allies and those with TMOTB. The same people are described by “*those who rule this people in Jerusalem*” (Isaiah 28:14), which is a poorly worded translation that relates to one of my spiritual titles, Jerusalem,

and is a reflection of me and the ‘church in Philadelphia’ being in “captivity”. Overall, this means that my foes have temporary authority over me and the rest of the ‘church in Philadelphia’ (Elekwachi, 2021a, Elekwachi, 2021d). The references to “*wine or strong drink*” (Isaiah 28:1, Isaiah 28:7) describes my foes being drunk on sins and lawlessness, with no intention of ceasing to act because of their own complacency. The very same is described by their tables being “*completely full of filthy vomit and filthiness*” (Isaiah 28:8), which conveys that their lawless behavior has resulted in a terrible mess that they tried to cover up with more lies and falsehood, but they cannot even clean up such a terrible mess because their actions went too far and have gone on for too long (Isaiah 28:15). The reason for this is because they have not stopped their wickedness, and would rather depend on false Satanic divination and prophecies to lead them to what they thought was “conquering” and “cleaning up the terrible mess”, rather than choosing to repent (Isaiah 28:7- 22). Therefore, Babylonians face the greatest consequences of the “end of the age”, which is simply reaping what they sowed. More so, those who continually support the agenda of Babylon will also face the same consequences, as what they have done and continually do is evil that is beyond pardon.

To conclude, it is worth noting that it was mentioned in ‘Calling: Special Edition’ (pg. 52) that illness could be caused and aggravated by other people, and so, this confirms that the Babylonian occult (and their allies) were truly making use of the demonic power of ‘Death’ in their persecution of Christians (I didn’t realize the full Truth when ‘Calling: Special Edition’ was written). Based on this “theory”, I can even explain some of the choices I made throughout my “fiery trial”, particularly before COVID-19 was announced. For example, when it was necessary for me to be around other people such as university, teaching placement, or when running errands, I realized that my condition temporarily worsened in response to the frequency and duration of exposure. In response to this discovery, I chose to go out only when it was necessary or expected by my family, and therefore, I purposefully avoided being exposed to my foes when studying, writing, creating and reviewing content for The VMFCP. This was because one consequence of prolonged exposure was being unable to focus on my work or other important tasks due to increased fatigue, migraines, pain and other issues. Therefore, when my foes persecuted me with the power of ‘Death’, my natural solution was “social-distancing and self-isolation”, even though I didn’t realize it at the time. Overall, this pattern is consistent with the COVID-19 restrictions, which is based on a model of “community spread”, and so, it remains that people “catch and spread ‘Death’” based on proximity, and therefore it must mean that uncontrolled ‘Death’ is simply a spiritual affliction that causes death by non-specific means; and this is what is labelled a COVID-19 death, whether someone has COVID-19 or not. Therefore, as noted in the first article of this series, ‘*The signs of the times: the mark of the beast is a metaphor*’, it remains that COVID-19 restrictions and the vaccine were a planned method of trying to control or minimize the damage done by Babylon to itself (the mortal

wound of the beast, Revelation 13:3, Revelation 17), which of course now effects most if not all nations across the world. Furthermore, with reports of mutant variants of COVID-19 that the vaccine(s) cannot cure or prevent, it makes the entire situation more suspect, for example, mutant variants of COVID-19 is probably a lie made up to “cover” the fact the vaccine is likely to be toxic i.e. it leads to death especially when ‘Death’ is directly influencing people’s health (Gallagher, 2020). More so, it follows that the distribution of the COVID-19 vaccine is labelled a trial for public liability purpose, and that is most likely because if people die from a toxic vaccine it cannot be blamed on those who created it. Lastly, it is also possible that ‘Death’ caused COVID-19 to mutate to a more deadly form, as it influences the ability to increase and spread disease, therefore, in the event that there was a legitimate vaccine provided to Babylonians only, the paying of their “fees” cannot be avoided. Hence, Babylon’s attempt at Christian genocide and mass human sacrifice using the “four horsemen of the apocalypse” is a complete failure because they cannot control divine powers. More so, it is known that physical death requires 2-factor authentication, and it is the Lord, the Most High God, who controls the second and master-step: who dies and who lives. Therefore, not even ‘Death’ is the true master of his own power.

DEATH IS NOT SIMPLE, IT IS MORE COMPLEX – JESUS CONTROLS THE MASTER-STEP OF DEATH.

The nature of death is worth explaining because the Bible presents it in a confusing manner, for example, it may look like demonic death (‘Death’) and God’s angel, the destroyer, are the same entity, but that is not the truth. Physical death is essentially a 2-step verification process, where satanic/demonic forces have the power to cause death, but it is the Lord, the Most High God, who actually decides if someone dies or not. Such things as who lives and who dies, and why, simply happens according to God’s will, and so, there is little point in pondering on such complex matters, but for the sake of comfort , it is worth expressing that although an innocent or righteous person may die (physical death), it remains that their destination is heaven (Abraham’s side or bosom, Luke 16:22). In addition, it is the Lord, the Most High God, who has absolute power over life and death, and therefore the power to save or destroy the soul, for it is written:

- **Revelation 1:17-18-**¹⁷ *When I saw him, I fell at his feet like a dead man. He laid his right hand on me, saying, “Don’t be afraid. I am the first and the last, ¹⁸and the Living one. I was dead, and behold, I am alive forever and ever. Amen. I have the keys of Death and of Hades.*
 - **NOTE:** “the Living One” refers to the Lord, Jesus Christ, and this Scripture is a acknowledgment to the fact that even though the demons ‘Death and Hades’ are mentioned in the book of Revelations, the Lord is saying that “My power is greater than the power of Death and Hades, and so, Christians should not fear them”.

- **Matthew 10:28** - ²⁸ *Don't be afraid of those who kill the body, but are not able to kill the soul. Rather, fear him who is able to destroy both soul and body in Gehenna.*
 - **NOTE:** People and demonic forces can kill other people, except Christians in captivity, and presumably those who are to be sealed i.e. the repentant among those with TMOTB, but people and demonic forces cannot determine the fate of the soul. Therefore, the Christians who were given over to the “sword” may have been killed, but their soul continues to live on in heaven. Therefore, the logical conclusion is that it is better to respect God and do His commandments because Christians always have a certain fate i.e. their soul will never be destroyed or condemned to hell.

To explain the master-step of death, it will be elaborated on using the Scripture, Exodus 12:21-23, and a few other Scriptures from the book of Job and Romans:

- **Exodus 12:21-23** - ²¹ *Then Moses called for all the elders of Israel, and said to them, “Draw out, and take lambs according to your families, and kill the Passover. ²² You shall take a bunch of hyssop, and dip it in the blood that is in the basin, and strike the lintel and the two door posts with the blood that is in the basin. None of you shall go out of the door of his house until the morning. ²³ For Yahweh will pass through to strike the Egyptians; and when he sees the blood on the lintel, and on the two door posts, Yahweh will pass over the door, and will not allow the destroyer to come in to your houses to strike you.*

The Scripture Exodus 12:21-23 indicates that the Lord, the Most High God, brought divine judgement on Pharaoh and the people of Egypt due to the continued persecution of His people, despite the signs and warning spoken by Moses and Aaron. In response to the death of children and suffering caused by Pharaoh who refused to let God’s people go: God sent out His angel, the destroyer, in an act of divine judgement which resulted in the firstborn of the Egyptians dying in an instant (Exodus 12). Obviously, the absence of demonic ‘Death’ in this circumstance indicates that the destroyer, is the only one with the true “license to kill”, which is the power to determine who lives and who dies based on the will of God (the Father). This is the master-step because it actually determines whether someone lives or physically dies. For example, a person could be drowned, poisoned, shot, stabbed, strangled, or persecuted with ‘Death’ for years, but if God (the Father) and therefore the destroyer, has no intention of taking their life by approving the “license to kill”, then that person cannot and will not die. Hence, by triggering the “end of the age”, the Lord, the Most High God has intervened in an Exodus-like manner, where the Christians who are in captivity are spiritually “covered” by the blood of the Lord Jesus Christ, the Lamb of God (Revelation 12:11), and are therefore able to “escape ‘Death’”. More so, although Christians may be persecuted by Babylonians wielding the power of ‘Death’, the destroyer, who is an angel of my God, would literally and naturally “Passover” Christians in captivity – which is equivalent to the Lord, the Most High

God, rejecting Babylon’s application for a “license to kill” Christians, or saying no to ‘Death’ on their behalf. This means that the “license to kill” is the second and master-step of death, and therefore, it is the only true barrier between life and death, and so, it remains that when and how someone dies is ultimately controlled by the Lord, the Most High God. Therefore, because there is no God- approved “license to kill” me or other Christians in captivity, our foes only have the opportunity to persecute us with ‘Death’. However, the use of ‘Death’ comes with a price, as this mode of persecution would be considered ‘sin that leads to death’ because the absence of a physical weapon in pre-meditated murder attempts does not minimize guilt, but rather it makes it worse (1 John 5:16, 1 John 3:15). The reason why it is considered worse is because it conveys this message: *“We know what we are doing is wrong, and we only try to hide our actions because all we really care about is looking innocent and “good”, rather than actually being innocent and “good”. We 100% believe that this plan is enough to trick Jesus into giving us favor during divine judgment, and so, we don’t have to worry about dying and going to hell at all. We are totally saved and should receive the Holy Spirit any minute now!”*. Obviously, the above statement is a lie and an example of the type of logic that gives rise to the practice of falsehood (Revelation 22:15). Therefore, the lesson is: (1) God would never favor or grant the Holy Spirit to murderous and terrorist-like people who practice falsehood, and (2) just because someone has access to power, it doesn’t mean that it is good or helpful to use it, especially when the power is for the purpose of causing death.

Continuing with the explanation of death, Satan and demons do not have a “license to kill”, but it is known that Satan has the power to cause death, and therefore, physical death is only based on whether or not there is a God-approved “license to kill”. This is made clear in the Book of Job, where Satanic influence caused Job’s servants and children to die, but that is because God must have granted them a “license to be killed”. However, God did not grant Satan a “license to kill” Job, and that was because He was a righteous and “good” man. More so, it is made clear in the Book of Job that when the power of ‘Death’ is not paired with a “license to kill”, then it can only result in troubles and sickness, but not physical death, which is exactly my experience and current circumstance (the same extends to the ‘church in Philadelphia’).

- **Job 1:6-18** - ⁶Now on the day when God’s sons came to present themselves before Yahweh, Satan also came among them. ⁷Yahweh said to Satan, “Where have you come from?” Then Satan answered Yahweh, and said, “From going back and forth in the earth, and from walking up and down in it.” ⁸Yahweh said to Satan, “Have you considered my servant, Job? For there is no one like him in the earth, a blameless and an upright man, one who fears God, and turns away from evil.”

⁹ Then Satan answered Yahweh, and said, “Does Job fear God for nothing? ¹⁰ Haven’t you made a hedge around him, and around his house, and around all that he has, on every side? You have blessed the work of his hands, and his substance is increased in the land. ¹¹ But stretch out your hand now, and touch all that he has, and he will renounce you to your face.”

¹² Yahweh said to Satan, “Behold, all that he has is in your power. Only on himself don’t stretch out your hand.” So Satan went out from the presence of Yahweh. ¹³ It fell on a day when his sons and his daughters were eating and drinking wine in their oldest brother’s house, ¹⁴ that a messenger came to Job, and said, “The oxen were plowing, and the donkeys feeding beside them, ¹⁵ and the Sabeans attacked, and took them away. Yes, they have killed the servants with the edge of the sword, and I alone have escaped to tell you.”

- **NOTE:** “Only on himself don’t stretch out your hand” reads as God says “you have no permission to physically harm Job or kill him, because I have decided not to let him die”. For further context, Job’s troubles were a test of his faith to determine whether Job’s faith was based on his status and material blessings or because he was truly a righteous man? The answer was that he was a righteous man who didn’t like sin.

Hence, demonic ‘Death’ is no threat to the innocent or repentant, but only to the guilty and those without proper moral conscience. Therefore, if your choice of actions during the “end of the age” have been terrible then they may catch up with you, especially for those who bear the curse of “blood guilt”, “eye for an eye, and a tooth for a tooth”, which means that if someone used ‘Death’ against me to cause a stroke, then the unrepentant person may have a stroke and then die. This is the most likely outcome if the said person accepted money or material benefits (mammon) to carry out such a wicked act against an innocent person. Therefore, it is known that the Lord, the Most High God, will also pay the unrepentant their wages, but not with money or spiritual blessings, but with a God-approved death i.e. a “license to be killed”. This means that God’s angel, the destroyer, will not “Passover” certain people due to the choices that they have made or continue to make, therefore resulting in their death and condemnation to hell due to their own wickedness. For it is written in Romans 6:23, ²³ For the wages of sin is death, but the free gift of God is eternal life in Christ Jesus our Lord. The Scripture Romans 6:23 conveys that people earn death, spiritually first and then literally, through their own choice of actions (lifestyle choices). Therefore, choosing to act wisely, such as by not purposefully committing sin is important during a time of divine judgement. Hence, the lessons of all this mess appears to be: (1) what it feels like to be at the mercy of a force much greater than yourself (2) what it feels like to be at the mercy of other people (3) how peoples choices affect the wellbeing and livelihood of others. Therefore, the test is

simply to reflect on these statements, and decide how you will respond from here onwards: repentance or rebellion?

REPENTANCE AND RELATIONSHIPS

If you have TMOTB and are genuinely repentant, and eventually receive the Holy Spirit then you are encouraged to make amends with the Christian(s) that you personally wronged, whether they knew/know it or not. However, this is only relevant if a genuine and significant relationship existed/exists (a relationship worth saving). As this leaves the possibility for a renewal or fixing of the relationship, whether it is between friends or extended family, for it is written:

- **Matthew 5:23-24** – ²³ “If therefore you are offering your gift at the altar, and there remember that your brother has anything against you, ²⁴ leave your gift there before the altar, and go your way. First be reconciled to your brother, and then come and offer your gift.
 - **NOTE:** Personal reconciliation requires a confession i.e. the admission of wrongdoing to the one who was wronged. Anyone who cannot admit such betrayal is not likely to be genuinely repentant (sorry), and it is impossible to trust someone who is not sorry. Therefore, because trust is required for a positive and genuine relationship to exist, an admission of wrongdoing and a demonstration of real change is obviously required for fixing a broken relationship. More so, this Scripture conveys that God will not listen to the prayers of those who refuse to make amends for their crimes against other people, as genuine repentance is typically signified by a choice of honest action towards the one who was wronged. This means that where possible making amends would be required for receiving the Holy Spirit.

However, where a pretend and unhealthy relationship exists, such as complacent sanctified spouses, or a circumstantial acquaintance that is only associated with persecution such as people met when completing a group assignment for university, the main point is to leave the wronged person alone i.e. the Christian. Therefore, it is time that people realize that their choices do not only have an effect on those that they persecute, but themselves, and that is because if people do not stop persecuting Christians, especially for money, then they know their fate. Hence, it is better to try and change instead of “knowingly” condemning yourself to eternal damnation in hell, and so, here is a more detailed explanation of “*a minimum of 50% of the entire world population will be saved as conveyed by the Scripture, Matthew 24:40-41*”, from the final DMW slides (Elekwachi, 2021c). It is known from Revelation 6:8, that the ‘pale’ horse has authority or power to kill over a fourth (one quarter) of the earth. However, “of the earth” reads of “the world” i.e. people with

TMOTB (unrepentant non-Christians). Furthermore, there are other considerations that have been taken into account, for the purpose of minimizing the total number of people with TMOTB who would “perish”, yet it is calculated according to lawful Biblical interpretation.

- A) The faithful Christian remnant and the Christians given over to the sword are excluded from calculations.
- B) The dependent children of the faithful Christian remnant are also excluded from the calculations.
 - A ‘dependent’ child is a person less than 18 years of age before the Second coming of Christ.
- C) The sanctified spouses of the faithful Christian remnant are excluded from calculations.
 - The ‘sanctified spouse’ must not be complacent i.e. not a persecutor of Christians and someone who lives a repentant lifestyle (which may lead to actual salvation).
 - Sanctification favors those with children (1 Timothy 2:15). Therefore, when a Christian-sanctified couple has no children, the only hope of the sanctified spouse is to not be complacent. Otherwise the only option for the non-Christian partner is to (1) leave willingly or (2) perish earlier than expected during divine judgement, and therefore the Christian spouse walks free of “dead weight”.
- D) The children of Christian-sanctified couples are also excluded from calculations.
 - A ‘sanctified’ child is a person less than 18 years of age before the Second coming of Christ.

Based on the above information and context that is drawn from Biblical evidence (Matthew 24:40-41), it remains that there is potential to redeem 50%-74.99% of “the world” population with TMOTB. Therefore, it is my hope and prayer that the Lord, the Most High God, in His great wisdom and mercy chooses to favor 74.99% because it is with skill, good conscience and lawful Biblical interpretation that these figures were generated (1 Timothy 1:8). With this knowledge it seems good to remind people that, ‘Calling: Special Edition’ was provided to help people begin to “see” and “hear” so that the likelihood of people genuinely choosing to live a Christian lifestyle is increased due to: (1) all these events making it easier to believe in Jesus Christ i.e. it boosts faith (2) most people would choose to repent and live, rather than being condemned to hell (3) all these events prove that Satan is a liar and a bad god, and so are other gods (4) the realization that the occult is not a helpful or a good contribution to society (5) the realization that “bad” choices have consequences on the one who does them, not just those who its done to (6) the realization that

“bad” choices can build up into a “cage”, which can affect the choices of other people, such as becoming Christian without the fear of persecution and the loss of livelihood, and (7) the realization that “good” leaders, whether Presidents, CEO’s, and church leadership is important because they have the power to break down the “cage”, and that is because it takes “big power” not “little power” to achieve certain things. Therefore, in all truth it is impossible for one person to be the entire Body of Christ, but it is the rest of the incoming Body of Christ that has yet to show any pro-activity, zeal or courage, and so, its time for other people to act, as all things are not my burden to bear or responsibility to do (1 Corinthians 12:12-26).

PARENTAL RESPONSIBILITY: THE TMOTB AND THE FATE OF THE SOUL

Some issues must be expressed so that (1) people begin to “see” the Truth and nature of the Lord, the Most High God and (2) people learn to take responsibility for their own choice of actions, whether it is one choice, or a series of choices. Therefore, it must be expressed that it is most likely that many parents have sold their own dependent children into the occult (selling a soul). This is clearly an issue that dates back generations, and is suspected because it has been observed that (1) most Babylonian young adults have TMOTB and (2) during my Master of teaching placements, when my understanding of the “the end of the age” was not as developed, it was noted that students as young as 12/13 displayed knowledge of the “end of the age”, which was determined through their use of certain phrases and “targeted” behaviors. Obviously, it is sad that children have been dragged into such a terrible mess and ugly times, and therefore, it needs to be expressed that children are not “human shields” from divine judgement. This means that being a mother or a father does not excuse them from judgement, instead it calls for greater love and responsibility for the lives of their own dependent children. Therefore, it is more likely that parents will be judged heavily on whether they choose to repent for the sake of their own children (an act of selflessness and true love). Regardless, this is why the Bible says ‘woe’ to those who have children:

- **Mark 13:17** - *¹⁷But woe to those who are with child and to those who nurse babies in those days!*

This obviously presents a daunting circumstance, however, there are other factors in play. For example, because dependent children of parents with TMOTB do not have the right to self-determination (cannot receive the Holy Spirit), it means they are not judged. Therefore, if a child dies it is God’s mercy and not an act of punishment (1 Kings 14:13). This also means that a child’s soul is sent to heaven (Abraham’s side or bosom, Luke 16:22), instead of being sentenced to hell, and as a result the child’s soul will be born again in the “new age of Christ”. There will most likely be the same extension of grace to those who come into adulthood just before the Second Coming of Christ, as some parental situations are just unfortunate. Hence, “reincarnation” has always been

part of the Christian faith, which was also pointed out in reference to Elijah and John the Baptist in the article, *'Inheritance: blood, culture and land heritage'* (Elekwachi, 2021a). For those who may be skeptical, there is even more evidence of reincarnation recorded in mainstream Bibles, and it is blatantly clear if you pay attention to subtle but obvious details. For example, the Lord, the Most High God says that He understands every temptation known to man, but how is it possible for God to understand the entire human experience if he has (1) only ever been perfect, and (2) only lived to the age of approximately 30 years old? (Hebrew 2:17). The answer is that it is impossible based on the above conditions, and so, this means that another Biblical figure was one of God's past lifetimes. If you are struggling to find the answer, here are some more clues to the Biblical mystery of reincarnation (1) there is a reason why the Lord, the Most High God, loves particular Biblical figures more than others, and (2) it appears that the soul of God was not always connected to His divinity, which is made clear by his lifestyle choices towards the latter end of his life. Hence, it was only when he was required to be divine that his holiness and perfection was manifested in full, and this is represented by the lifetime He lived as the Messiah, the Lord Jesus Christ. Overall, it seems that God had to learn to be human by being human, and it was his different life experiences that developed His full and complete understanding of the human condition, which enabled Him to become a merciful and faithful high priest for mankind (Hebrews 2:17).

Hence, it is only the truly "bad" adults, who are souls that never choose to learn better or redeem themselves that do not and will not survive divine judgement. Therefore, be reminded that it is the "end of the age", which means that there is a limited amount of time to commit to change, and so, if you struggle with believing in the Lord, the Most High God, then be reminded of your own experiences, my teachings, my testimony, and then perhaps you will begin to "see" the Truth and listen to instruction. More so, this is clearly a terrible mess that can only be used to provide opportune deliverance and peace of mind to those who choose to change, and so, if you choose to begin truly repenting today, then you need not fear divine judgement or the eternal damnation of your soul. Therefore, to those who understand English, " a last chance can last awhile, but do not wait until it's too late"; and to my people, the Ndigbo, "onye furu utu rachaa utu, anaghi afu utu mgbenile".

ARTICLE PINPOINT

Here is a lesson on Biblical context that helps make the Book of Revelation a bit easier to understand. The Lord and His angels also have white horses, but they are not demonic (Revelation 19:11-14), the horses simply represent the Heavenly origin of their power. After all, Satan and his demons were once of heavenly origin, but they were demoted because of their rebellion and sins. The same concept also applies to stars, for example, the twelve stars on the head of the Revelation 12 woman represents the Lord's anointing. As for the stars that Satan caused to fall to the earth (Revelation 12:4): these are demons. Demons are "fallen" angels i.e. heavens outcasts, and because they originate from heaven they are described as stars, but they are evil stars. Therefore, a star is typically a positive Biblical description and this is confirmed by the reference to stars as good in Daniel 12:3, with "shining like stars" conveying eternal life (immortality) and untold blessings, and in Genesis 37:9, where the stars represented his brothers, the 11 patriarchs of Israel and their families, who Joseph eventually saved and rose to power over in the days of Pharaoh, the King of Egypt.

It is of note that Satan's fall from heaven represents the fall of Babylon's Satanic dominion that is associated with the efforts of the Revelation 12 woman (me). Therefore, let it be known that the troubles that I have experienced for years are the result of the Lord bestowing me with multiple spiritual titles. This means that the Lord technically cursed me, so that the blessings attached to the Spiritual titles can also take effect through the infallibility of His Word. Therefore, it needs to be made clear that I did not, and do not suffer for any great evil (sins), meaning that my troubles are more like Job and Ezekiel's. In direct contrast, great evil (sins) is the exact reason for divine judgment, and so, whatever the Babylonian occult summoned and released is not greater than the power of the Lord, the Most High God despite what people may be experiencing (Hebrew 2:8). After all, Satan, His anti-Christ, the "kings" and the Body of Satan are still subject to the Lord's will, which He enforces for the sake of Christians and their salvation. For example, to this day my enemies cannot physically harm me or Christians in captivity, and so, it follows that TMOTB was essentially turned into a leash that protects Christians (faithful and repentant) from those who would choose to murder and torture them given the opportunity (Revelation 22:15). Hence, Babylon's downfall will be an unsuspecting Christian woman in captivity who responded to the "abomination of desolation" by teaching the Truth in the form of eBooks, and so, it is through "writer's voice" (the current rod of my mouth, Isaiah 11:4) that the Lord, the Most High God, is once again putting Satanic principalities and powers to open shame.
